RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, Grantor has requested that the Administrative Agent release and reassign its interest in the trademarks more fully identified in Schedule I annexed hereto and made a part hereof (the "**Released Trademarks**") and all related rights, title and interest of Grantor in the Released Trademarks;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Administrative Agent hereby:

1. releases and reassigns to Grantor any and all liens, security interests, right, title and interest of Administrative Agent granted pursuant to the IP Security Agreements in the Released Trademarks, without recourse or representation or warranty, express or implied, of any kind or nature whatsoever;
2. agrees that any power of attorney or similar rights granted by Grantor to the Administrative Agent pursuant to any IP Security Agreement is terminated with respect to the Released Trademarks; and
3. authorizes and requests that the Patent and Trademark Office note and record the existence of the release hereby given.
