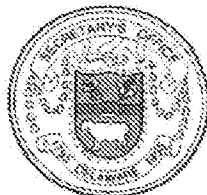

This Certificate of Conversion to Limited Liability Company, dated as of January 22, 2021, has been duly executed and is being filed by Newgistics, Inc., a Delaware corporation (the "Corporation"), to convert the to Pitney Bowes Global Logistics LLC, a Delaware limited liability company (the "LLC"), Corporation under the Delaware Limited Liability Company Act (6 Del. C. § 18-101, et seq.) and the General Corporation Law of the State of Delaware (8 Del. C. § 101, et seq.).

1. The Corporation filed its original certificate of incorporation with the Secretary of State of the State of Delaware and was first incorporated on December 1, 1999 under the name "iReturnit, Inc." in the State of Delaware, and was incorporated in the State of Delaware immediately prior to the filing of this Certificate of Conversion to Limited Liability Company.
