**Trademark Assignment**

This Trademark Assignment ("Assignment"), effective as of February 24, 2021 ("Effective Date"), is entered into by and between:

- TGIB Marketing Inc., a corporation formed under the laws of the State of New York, with an address of 1250 Scottsville Road, Suite 3, Rochester, New York 14624 ("TGIB") and
- Alan Slade and Jean Lisa Slade, individuals with addresses at 160 Northfield Avenue, Edison, New Jersey 08837 (the "Slades").

TGIB and the Slades are referred to collectively as the "Parties" and individually as a "Party."



WHEREAS, the Slades own rights in and to the trademark (the "Mark"), United States Trademark Registrations 6020631, 5937171, and 5749094 for the Mark (the "Registrations"), and the goodwill of the business symbolized thereby (the Mark, Registrations, and goodwill are referred to collectively as the "Trademarks");

WHEREAS, the Slades desire to convey, transfer, assign, deliver, and contribute to TGIB all of their right, title, and interest in and to the Trademarks and TGIB desires to acquire the Trademarks;

NOW, THEREFORE, in consideration of the premises and agreements contained herein, the receipt and sufficiency of which is hereby acknowledged, the Parties agree as follows:

The Slades hereby assign, transfer, grant, convey, and relinquish to TGIB all right, title, and interest in and to the Trademarks, including, but not limited to, the right to sue for and recover damages with respect to past infringements of the Trademarks, as fully and completely as permitted by law, it being the intention of the Parties that TGIB shall acquire all rights in the Trademarks, leaving the Slades with no rights whatsoever.
