It is hereby certified that:

1. The name of the corporation (hereinafter called the "Corporation") is Axial Biotherapeutics, Inc. and that this corporation was originally incorporated under the name Neurobiotix Health, Inc., pursuant to the General Corporation Law of the State of Delaware on December 19, 2013.
2. Thereafter, a Restated Certificate of Incorporation was filed on June 18, 2019 with the Secretary of State of the State of Delaware and such Restated Certificate of Incorporation was amended by that certain Certificate of Amendment filed on May 7, 2020 with the Secretary of State of the State of Delaware (as amended, the "Restated Certificate"). The Restated Certificate is hereby amended by deleting in its entirety Article FIRST thereof and replacing it with the following new paragraph FIRST:

"FIRST: The name of this corporation is Axial Therapeutics, Inc. (the "**Corporation**").
3. The amendment of the Restated Certificate of Incorporation herein certified has been duly adopted in accordance with the provisions of Section 242 of the General Corporation Law of the State of Delaware.
