**RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS**

This RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS (“**Release**”), effective as of March 16, 2021, given by Wells Fargo Bank of Texas, National Association, with an address at 1000 Louisiana, 3<sup>rd</sup> Floor, Houston, TX 77002, as Collateral Agent for the Secured Parties (“**Agent**”) to Oil States International, Inc., a Delaware corporation, with an address at 7701-A South Cooper, Arlington, TX 76001 (“**Grantor**”), as follows:

**W I T N E S S E T H**

WHEREAS, pursuant to that certain Credit Agreement dated as of October 30, 2003 (as amended, supplemented or otherwise modified from time to time, the “**Credit Agreement**”), the Lenders (as defined in the Credit Agreement) have agreed to extend credit to the U.S. Borrower (as defined in the Credit Agreement);

WHEREAS, in connection with the Credit Agreement, the Grantor executed that certain U.S. Security Agreement, dated as of October 30, 2003 (as amended, supplemented or otherwise modified from time to time, the “**Security Agreement**”), which was recorded by the U.S. Patent and Trademark Office on November 12, 2003, at Reel / Frame no. 2745 / 0714, and granted to the Agent a security interest in the United States trademark registrations and applications set forth on Schedule A attached hereto (the “**Trademarks**”);


WHEREAS, the Agent wishes to release and restore all right, title and interest in and to the Trademarks to the Grantor and to terminate the encumbrance created by the Security Agreement and the Collateral Agreement in respect of the Trademarks.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Agent hereby terminates, releases, cancels, relinquishes and discharges the security interest in the Trademarks created by the Security Agreement and the Collateral Agreement and reassigns all right, title and interest it has in the Trademarks to the Grantor.

THIS RELEASE SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF TEXAS AND SHALL BE BINDING UPON THE GRANTOR’S AND THE COLLATERAL AGENT’S REPRESENTATIVES, SUCCESSORS, ASSIGNS AND TRANSFEREES.
