**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Trademark Release”) is made as of March 19, 2021 by **UBS AG, STAMFORD BRANCH** (the “Collateral Agent”) in favor of **OPEN LENDING, LLC**, a Texas limited liability company with an address at 901 S. Mopac Expressway, Building 1, Suite 510, Austin, Texas 78746 and **LENDERS PROTECTION, LLC**, a Delaware limited liability company with an address at 901 S. Mopac Expressway, Building 1, Suite 510, Austin, Texas 78746 (each, a “Grantor” and collectively, the “Grantors”).

WITNESSETH:

WHEREAS, the Grantors entered into a certain trademark security agreement dated March 11, 2020 (the “Trademark Security Agreement”) with Collateral Agent, notice of which was recorded on March 12, 2020 at the United States Patent and Trademark Office at Reel 6890, Frame 0360.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, each Grantor granted the Collateral Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Collateral Agent, in and to all of each such Grantor’s right, title and interest in the Trademark Collateral, including without limitation the Trademarks listed in Schedule A.


WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges any and all of its interest in the Trademark Collateral of the Grantors, including and all of the goodwill associated with or symbolized by the Trademark Collateral, and assigns, transfers and conveys to each Grantor any interest in such intellectual property, including the Security Interest.


