Trademark Purchase and Assignment Agreement

This Trademark Purchase and Assignment Agreement (the "Agreement") is made as of January 21, 2021, (the "Effective Date"), between George R. Thomas, III (the "Assignor") and Yellow Bird Real Estate, Inc. (the "Assignee").

The Assignor is the registered owner of a mark, "YELLOW BIRD REAL ESTATE," that is registered in the United States Patent and Trademark Office, Registration No. 3472065, dated July 22, 2008.

The Assignee wishes to acquire the Assignor's rights in the trademark listed in this agreement.


The Assignee agrees to pay the Assignor's purchase price.

- 3) all rights to sue for past, present and future infringement or misappropriations of the marks.

The Assignor further covenants that it will take all actions that may be necessary for securing, completing, or vesting in the Assignee full right, title, and interest in the mark and its related property.
