TRADEMARK ASSIGNMENT AGREEMENT

This Assignment Agreement is made by and between:

NOW THEREFORE, the parties agree that for and in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration, the receipt of which is hereby acknowledged, Dr. Allan Coopersmith does hereby assign and transfer and set over to Telebrands its successors, legal representatives and assigns, all rights, title, and interests derived from and in connection with said Trademark, together with the goodwill associated therewith and the right to sue for past infringements.

Telebrands unconditionally and irrevocably agrees to assign the trademark back to Dr. Allan Coopersmith upon expiry of the Marketing and License Agreement dated May 17, 2018 between Telebrands and Allnat Innovations Inc. upon its terms, or at such earlier date as the parties may agree.

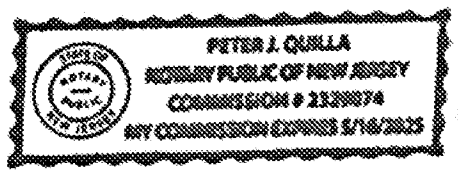
