**TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN
TRADEMARKS**

This Termination and Release of Grant of Security Interest in Trademarks (this "Termination and Release") is granted as of March 3, 2021, by **HORIZON TECHNOLOGY FINANCE CORPORATION**, (the "Secured Party"), in favor of **CAPITOL POWER GROUP, L.L.C.**, a Virginia limited liability company (the "Debtor").

WHEREAS, the Debtor has requested that the Secured Party provide a document suitable for recording with the USPTO to evidence the release of the Secured Party's security interests in and liens on the Marks as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby:

1. terminates the Grant and releases, terminates and discharges all liens and security interests in the Debtor's right, title and interest in, to and under the Marks, and all goodwill associated therewith, including those trademarks and trademark applications identified in Schedule A hereto; and
2. authorizes and requests that this Termination and Release be recorded with the USPTO.
