**TERMINATION AND RELEASE OF
SECURITY INTEREST IN INTELLECTUAL PROPERTY**

This Termination and Release of Security Interest in Intellectual Property (“Release”) is made this 19th day of March, 2021, by AVIDBANK a California corporation, (the “Bank”), in favor of MST SERVICES, LLC, a Delaware limited liability company (the “Grantor”).

WHEREAS, pursuant to the terms and conditions of that certain Security Agreement by Grantor in favor of Bank, dated October 28, 2016 (the “Security Agreement”), and recorded with the U.S. Patent and Trademark Office on January 25, 2017 at Reel/Frame No. 005971/0278, pursuant to which the Grantor granted to Bank a continuing security interest in all of Grantor’s right, title and interest in, to and under the Collateral (as defined in the Security Agreement);

WHEREAS, Grantor and Bank entered into the Security Agreement in connection with that certain Credit Agreement dated as of October 28, 2016 (the “Credit Agreement”);

WHEREAS, the Grantor’s Obligations (as defined in the Credit Agreement) under the Credit Agreement have been satisfied in full and the security interest granted to Bank pursuant to the Security Agreement has been released by Bank;

WHEREAS, Bank has the requisite power and authority to release and discharge its security interest in and to the Collateral (as defined in the Security Agreement); and

WHEREAS, the parties desire to confirm and evidence the termination and release of the security interest in, to and under the Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Bank, on behalf of itself and its successors, legal representatives and assigns, hereby unconditionally, irrevocably and absolutely (i) terminates the Security Agreement, (ii) assigns to Grantor, without any representation, warranty, or recourse whatsoever, all of Bank’s right, title and interest (if any) in and to the Trademarks and (iii) terminates, cancels, releases and forever discharges any and all security interests it holds in, to and under the Trademarks, including, without limitation, the Trademarks set forth on **Exhibit A**.

Bank shall take all further reasonable actions, and provide to Grantor or their successors, assigns or other legal representatives, all such reasonable cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by Grantor to more fully and effectively effectuate the purposes of this Release, in each case, at Grantor’s expense. By this instrument, Bank authorizes and requests Grantor to record this Release with the USPTO.
