Assignee shall file this Agreement with the Assignments Division (Trademarks) of the United States Patent and Trademark Office and Assignee may also take any and all additional actions and file all documents as may be necessary or convenient which relate to the Mark with the World Intellectual Property Organization and foreign trademark offices.




