WORLDWIDE ASSIGNMENT

WHEREAS, this Trademark Assignment (the "Assignment") is made as of March 15, 2021 (the "Effective Date");

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns, transfers, and conveys absolutely to Assignee, and its lawful successors and assigns, Assignor's entire right, title, and interest in and to the aforesaid Rights to the Trademarks in existence as of the Effective Date.

Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States and any appropriate official of any foreign country whose duty is to register trademarks on applications as described above, to issue all registrations under said Rights to Assignee, its successors and assigns, in accordance with the terms of this Assignment;

Assignor hereby covenants that Assignor has the full right to convey the interests assigned by this Assignment, and that Assignor has not executed and will not execute any agreement in conflict with this Assignment;


And, the aforesaid Assignment includes (1) the goodwill of the business relating to the goods and services with respect to which the Trademarks are used and for which they are registered; (2) all income, royalties, damages and payments now or hereafter due or payable with respect to any trademark registrations which may be granted; and (3) all causes of action (whether in law or in equity); and the right to sue, counterclaim, and recover for past, present and future infringement of the Rights assigned or to be assigned under this Assignment, as fully and entirely as the same would have been held and enjoyed by Assignor if this sale and assignment had not been made;

Assignor further covenants and agrees that, upon request of Assignee, Assignor will, without further consideration, communicate with Assignee, its successors and assigns, any facts known to Assignor respecting the Trademarks, sign and deliver all lawful papers when called upon to do so, including Declarations, Oaths, Powers of Attorney, Assignments, and Affidavits for or in relation to the Rights, and to aid Assignee, its successors and assigns, to obtain and enforce proper registration and protection for the Trademarks in the United States and any foreign country, it being understood that any expense incident to the execution of such papers shall be borne by Assignee, its successors and assigns.

The undersigned hereby authorizes the firm of J.A. Lindeman & Co., PLLC to correct any errors in this Assignment or to insert any further identification or other information necessary or desirable to make this Assignment suitable for recording in any country.



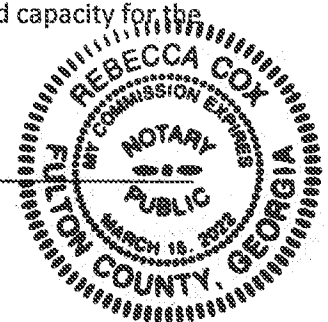
