CONFIRMATION OF ASSIGNMENT OF RIGHTS IN IP SECURITY AGREEMENTS


- A. **WHEREAS** MEC Mountain Equipment Company Ltd., formerly MEC Canada Inc. (the “**Grantor**”) is the owner of: (a) the trademarks set forth in Exhibit A, the registrations and applications for the trademarks identified therein and the underlying goodwill associated with the foregoing as well as all the goodwill of the business connected to and symbolized by the such trademarks, (collectively, the “**Trademarks**”); and (ii) the copyright applications and registrations set forth in Exhibit A (collectively, the “**Copyrights**” and, together with the Copyrights and the Trademarks, the “**Intellectual Property**”).
- B. **WHEREAS** the Grantor entered a trademark security agreement and a copyright security agreement dated October 30, 2020 (collectively, the “**IP Security Agreements**”) with Gordon Brothers Finance Company (“**Gordon Brothers**”), in its capacity as administrative agent and collateral agent for each member of the Credit Parties, as defined in, and under, a certain credit agreement dated as of October 30, 2020 (as amended, restated, supplemented, or otherwise modified from time to time).
- C. **WHEREAS** under the IP Security Agreements, the Grantor, among other things, granted to Gordon Brothers a security interest in certain property, including the Intellectual Property, as security for the obligations described therein.
- D. **WHEREAS** Gordon Brothers entered into an assignment, resignation and appointment of agent agreement dated January 13, 2021 (the “**Assignment Agreement**”) with among others, Callodine Commercial Finance, LLC (the “**Successor Agent**”), pursuant to which: (a) Gordon Brothers resigned as administrative agent and collateral agent for the IP Security Agreements and assigned all of its rights, powers, privileges and duties under the IP Security Agreements to the Successor Agent; and (b) the Successor Agent was appointed as administrative agent and collateral agent for the IP Security Agreements and expressly assumed the rights, powers, privileges and duties thereunder.

NOW, THEREFORE, in consideration of the premises and mutual covenants herein contained and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and in accordance with the terms and obligations set forth in the Assignment Agreement, Gordon Brothers confirms the appointment of the Successor Agent as administrative agent and collateral agent for the IP Security Agreements and the assignment to the Successor Agent of all of Gordon Brothers’ rights, powers, privileges and duties under the IP Security Agreements.




