RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of January 29, 2021 (the “Effective Date”), is made by DEUTSCHE BANK TRUST COMPANY AMERICAS, in its capacity as notes collateral agent pursuant to the Indenture (in such capacity, the “Notes Collateral Agent”), in favor of Refinitiv US Organization LLC (formerly known as Thomson Reuters (GRC) Inc.), a Delaware limited liability company (the “Grantor”) and its Affiliates.

WHEREAS, pursuant to that certain Security Agreement, dated as of October 1, 2018, by and among the Notes Collateral Agent, the Grantor and certain other parties thereto (as amended, amended and restated, or otherwise modified from time to time, the “Notes Security Agreement”), the Grantor granted to the Notes Collateral Agent, in its capacity as Notes Collateral Agent for the benefit of the Secured Parties, a lien on and security interest in, to and under all of its right, title, and interest in, to and under the Trademark registrations and applications of the Grantor, including those listed on Schedule A attached hereto, together with all goodwill associated therewith;

WHEREAS, pursuant to the Notes Security Agreement, the Grantor executed and delivered, in favor of the Notes Collateral Agent, in its capacity as Notes Collateral Agent for the benefit of the Secured Parties, a Trademark Security Agreement (Short Form), dated as of October 1, 2018 (the “Trademark Security Agreement”) for recordal with the United States Patent and Trademark Office;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on October 3, 2018 at Reel/Frame 6448/0342;

WHEREAS, a Partial Release of Trademark Security Agreement, dated as of February 13, 2019, under which the Notes Collateral Agent executed and delivered the release of the Security Interest in two Trademarks (Registration Nos. 2,201,787 and 3,637,759), was recorded with the United States Patent and Trademark Office on March 1, 2019 at Reel/Frame 6578/0220;

WHEREAS, a Partial Release of Trademark Security Agreement, dated as of September 28, 2020, under which the Notes Collateral Agent executed and delivered the release of the Security Interest in one Trademark (Registration No. 4,505,163), was recorded with the United States Patent and Trademark Office on October 8, 2020 at Reel/Frame 7073/0043;

WHEREAS, the Notes Security Agreement and Trademark Security Agreement have terminated and all liens thereunder were released automatically in accordance with Section 6.11 of the Notes Security Agreement;

WHEREAS, in accordance with Section 6.11(d) of the Notes Security Agreement, the Notes Collateral Agent shall execute and deliver to any Grantor all documents that such Grantor shall reasonably request to evidence such termination or release;

NOW, THEREFORE, in accordance with Section 6.11 of the Notes Security Agreement, and for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Notes Collateral Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Notes Security Agreement or the Trademark Security Agreement, as applicable.

2. Release. The Notes Collateral Agent, without representation or warranty of any kind, hereby acknowledges the automatic release, discharge, termination and cancellation of, and hereby releases, discharges, terminates and cancels all of, its Security Interest in, to and under all Trademark registrations and applications of the Grantor, including, without limitation, those listed on Schedule A attached hereto, arising under the Notes Security Agreement and the Trademark Security Agreement and all Proceeds of the foregoing (the "Trademark Collateral"). If and to the extent that the Notes Collateral Agent has acquired any right, title or interest in and to the Trademark Collateral, the Notes Collateral Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Grantor.

3. Termination. The Notes Collateral Agent, without representation or warranty of any kind, acknowledges the automatic termination and cancellation of, and hereby terminates and cancels the Trademark Security Agreement.


4. Further Assurances. The Notes Collateral Agent agrees to take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor, at the Grantor's sole cost and expense, to more fully and effectively effectuate the purposes of this Release. The Notes Collateral Agent hereby authorizes and requests that the Commissioner for Trademarks of the United States Patent and Trademark Office record this Release.

5. Governing Law. This Release shall be governed exclusively under the laws of the State of New York, without regard to conflicts of law or choice of law principles.
