WHEREAS, Wells Fargo Capital Finance, LLC (successor-by-merger of Wells Fargo Capital Finance, Inc., formerly known as Wells Fargo Foothill, Inc., formerly known as Foothill Capital Corporation) assigned its rights under the Security Agreement to Agent (formerly known as Laidlaw International, Inc.) pursuant to that certain Assignment of Liens and Security Interests dated March 1, 2021, and recorded in the United States Patent and Trademark Office in Trademark Reel 7229 Frame 0525 on March 23, 2021; and

WHEREAS, the obligations pursuant to Security Agreement have been satisfied and the Agent no longer claims an interest in the Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is acknowledged, Agent hereby releases to Grantor the security interest in, to and under the Collateral, including without limitation the Collateral identified on Exhibits A and B.


