**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**, dated as of March 24, 2021 (the "Release"), is made by Gibraltar Business Capital, LLC, a Delaware limited liability company ("Lender"), in favor of Garsite Progress, LLC, a Delaware limited liability company ("Grantor").


**WHEREAS**, pursuant to that certain Intellectual Property Security Agreement dated as of March 6, 2020, by and between Lender and Grantor, recorded with the United States Patent and Trademark Office (the "USPTO") (i) with respect to patents on March 10, 2020 at reel 052071 frame 0063 and (ii) with respect to trademarks on March 10, 2020 at reel 6887 frame 0584 (the "Security Agreement"). Lender hereby acknowledges that this Release may be filed along with any other necessary documentation with the USPTO or any other governmental office to evidence the release granted herein at the sole expense of the Grantor. Lender authorizes the Grantor or its designees to record this Release with the USPTO and any other applicable registry at the sole expense of the Grantor.
