## TRADEMARK AND PATENT SECURITY AGREEMENT

THIS TRADEMARK AND PATENT SECURITY AGREEMENT (the "Agreement") made as of this 24th day of March 2021 by BRIGHTON-BEST INTERNATIONAL, INC., a California corporation ("Grantor"), in favor of PNC BANK, NATIONAL ASSOCIATION, in its capacity as collateral agent for the Lenders ("Collateral Agent").

### W I T N E S S E T H

WHEREAS, Grantor has entered into that certain Second Amended and Restated Revolving Credit and Security Agreement dated the date hereof (as the same may hereafter be amended, restated, supplemented or modified from time to time, the "Credit Agreement") with the financial institutions party thereto from time to time as lenders (collectively, the "Lenders"), Collateral Agent, EAST WEST BANK ("East West"), as administrative agent for the Lenders (East West in such capacity, "Administrative Agent"), and as Sole Arranger and a Joint Book Runner, JPMORGAN CHASE BANK, N.A., as Documentation Agent and a Joint Book Runner, and BANK OF TAIWAN, as Syndication Agent pursuant to which the Lenders have agreed to make loans and advances to Borrower;

WHEREAS, as security for the Obligations under the Credit Agreement, Grantor has granted to Collateral Agent, for the benefit of Lenders, a security interest in substantially all of the assets of Grantor including all right, title and interest of Grantor in, to and under all now owned and hereafter acquired trademarks and patents, together with the goodwill of the business symbolized by Grantor's trademarks and patents and all products and proceeds thereof, to secure the payment of all amounts owing by Borrowers under the Credit Agreement;

NOW, THEREFORE, in consideration of the premises set forth herein and for other good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, Grantor agrees as follows:

1. Incorporation of Credit Agreement. The Credit Agreement and the terms and provisions thereof are hereby incorporated in their entirety by this reference. All terms capitalized but not otherwise defined herein shall have the same meanings ascribed to them in the Credit Agreement.

2. Grant and Reaffirmation of Grant of Security Interests. To secure the payment and performance of the Obligations under the Credit Agreement, Grantor hereby grants to Collateral Agent, for its benefit and the benefit of Lenders, and hereby reaffirms its prior grant pursuant to the Credit Agreement of a continuing security interest in Grantor's entire right, title and interest in and to the following whether now owned or existing or hereafter created, acquired or arising:

(i) each trademark and trademark application, patent and patent application listed on Schedule 1 annexed hereto (such trademarks and trademark applications, the "Trademarks"; and such patents and patent applications, the "Patents"), together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark; and

(ii) all products and proceeds of the forgoing, including without limitation, any claim by Grantor against third parties for past, present or future infringement or dilution of any Trademark or Patent, or injury to the goodwill associated with any Trademark or Patent.

3. Covenants. Except as otherwise permitted under the Credit Agreement, Grantor agrees not to sell, license, grant any option, assign or further encumber its rights and interest in the Trademarks or Patents without prior written consent of Collateral Agent.

4. Representations and Warranties. Grantor hereby represents and warrants that the Trademarks and Patents listed on Schedule 1 attached hereto constitute all trademarks and trademark applications and patents and patent applications owned or registered to Grantor as of the date of this Agreement that are not subject to the security interest and lien of Collateral Agent.

5. Counterparts. This Agreement may be executed in any number of counterparts, all of which shall constitute one and the same instrument, and any part hereto may execute this Agreement by signing and delivering one or more counterparts. Delivery by facsimile or electronic transmission shall bind the parties hereto.

6. Governing Law. This Agreement and the transactions contemplated hereby, and all disputes between the parties under or relating to this Agreement or the facts or circumstances leading to its execution, whether in contract, tort or otherwise shall be construed in accordance with and governed by the laws (including statutes of limitation) of the State of New York, without regard to conflicts of law principles that would require the application of the laws of another jurisdiction.

7. Termination. This Agreement and the Liens and security interests granted hereunder shall automatically terminate upon a termination of the Credit Agreement pursuant to and in accordance with Article XIII thereof.


