**MEMORANDUM AND NOTICE OF
SECURITY INTEREST IN INTELLECTUAL PROPERTY**

MUSCO OLIVE PRODUCTS, INC., a California corporation (“Debtor”) hereby acknowledges that, pursuant to that certain Loan, Guaranty and Security Agreement dated as of the date hereof (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Loan Agreement”) by and among the Debtor, the other loan parties party thereto, the financial institutions party thereto as lenders and Agent, it has granted to **BANK OF AMERICA, N.A.**, a national banking association (“Agent”), whose address is Bank of America, N.A., 333 S. Hope Street, 19th Floor, Los Angeles, California 90071, for the benefit of the Secured Parties, a Lien on, among other personal Property of Debtor, the trademarks and trademark registrations which are identified on Exhibit A attached hereto and herein incorporated by this reference owned Debtor (the “Trademarks”) (but excluding any intent-to-use trademark applications filed in the United States Patent and Trademark Office) to secure the prompt payment and performance of the Obligations (as defined in the Loan Agreement) as set forth in the Loan Agreement.

The terms and conditions of the aforementioned security interest are contained in the Loan Agreement. Nothing contained in this Memorandum and Notice of Security Interest in Intellectual Property shall be construed as a present or absolute assignment of any of the collateral nor as limiting any interest which Agent may have in any other collateral described in the Loan Agreement or otherwise.

The parties hereby agree that this Memorandum and Notice of Security Interest in Intellectual Property and all claims shall be governed by the law of the State of New York, without giving effect to any conflict of law principles except federal laws relating to national banks and Sections 14.14 and 14.15 of the Loan Agreement are hereby incorporated by reference. Debtor hereby authorizes the filing of this Memorandum and Notice of Security Interest in Intellectual Property with the United States Patent and Trademark Office.


