Assignor further covenants that it will take all actions that may be necessary for securing, completing, or vesting in Assignee’s full right, title, and interest in the Marks and its related property.

This Assignment shall be sufficient evidence of the transfer to Assignee of the Marks and may be submitted to the U.S. Patent and Trademark Office (the “**USPTO**”) as evidence of Assignee’s ownership of the Marks. Assignor hereby authorizes the USPTO to record and register this Assignment upon request by Assignee.
