## TERMINATION AND RELEASE OF TRADEMARK SECURITY INTEREST

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY INTEREST (“**Release**”), is made and effective as of this 9th day of March, 2021, and granted by CITIZENS BANK, N.A. (as successor by merger to CITIZENS BANK OF PENNSYLVANIA) (the “**Bank**”), in favor of KOMLINE-SANDERSON CORPORATION, a New Jersey corporation (“**Komline**”).

WHEREAS, pursuant to the terms and conditions of that certain Patents, Trademarks, Copyrights and Licenses Security Agreement by and between the Bank and Komline dated as of March 28, 2018, (the “**Security Agreement**”), Komline granted to the Bank a continuing security interest in and to all of Komline’s right, title and interest in and to the Trademarks (as defined in the Security Agreement), including all of the trademarks set forth on **Schedule A** attached hereto;

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on July 11, 2018, at Reel 006377, Frame 0814; and


WHEREAS, the Bank has agreed to terminate and release its security interest and all of its right, title and interest in and to each of the Trademarks.
