NUNC PRO TUNC TRADEMARK ASSIGNMENT

WHEREAS, HTI USA, Inc., a Michigan corporation having an address of 33106 W. Eight Mile Road, Farmington Michigan 48336 ("*Assignor*"), was the owner of all right, title and interest in and to the trademark CAPTAIN'S CHOICE, logos and design marks associated therewith and any variations thereof, and all common law rights related thereto, including the trademarks shown on **Schedule A** (the "*Marks*");

WHEREAS, Assignor agreed to transfer the Marks on February 28, 2017 to Sam Brown Sales, LLC, a Delaware limited liability company having an address of 33106 W. Eight Mile Road, Farmington, Michigan 48336 (the "*Assignee*") in conjunction with the Unit Purchase Agreement between the Parties dated February 28, 2017.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby assigns to Assignee, *nunc pro tunc*, as of February 28, 2017, all right, title and interest in and to the Marks together with the goodwill of the business symbolized by the Marks, the corresponding U.S. Trademark Registrations for the Marks and any other applications or registrations for the Marks, and any renewals thereof, and all common law rights associated with the Marks; the right to sue or otherwise recover for any and all past, present and future infringement or dilution of the Marks; all income, royalties, damages, and other payments now and hereafter due and payable with respect to the Marks; and all other rights, whether statutory or common law, corresponding thereto and all other rights of any kind whatsoever accruing thereunder.

Assignor further agrees to execute all documents, papers, forms, and authorizations and to take any and all other actions that may be necessary for securing, completing, or vesting in Assignee full right, title and interest in and to the Marks.

Assignor hereby requests the United States Commissioner of Trademarks and the corresponding entities or agencies in any applicable foreign countries, to record Assignee as the sole owner of the Marks.
