This Confirmatory Assignment shall be governed by and construed in accordance with the laws of the State of New York, without giving effect to any choice of law or conflict of law provision or rule that would cause the application of the laws of any jurisdiction other than the State of New York. The parties agree that the United States District Court for the Southern District of New York shall have exclusive jurisdiction of any dispute with respect to this Confirmatory Assignment. Both the Assignor and Assignee irrevocably agree that such suits, actions or proceedings may only be commenced or prosecuted in such court, and each irrevocably waives any claim that any such court constitutes an inconvenient forum for the prosecution of such suit, action or proceeding. Both of the parties irrevocably agree not to seek the transfer of any such suit, action or proceeding to any court located outside of the United States District Court for the Southern District of New York.
