**TERMINATION AND RELEASE OF  
DOMESTIC INTELLECTUAL PROPERTY SECURITY AGREEMENT**

**March 29, 2021**

WHEREAS, ROSY BLUE, INC., a New York corporation, ROSY BLUE JEWELRY INC., a New York corporation, ROSY BLUE FINE, INC., a New York corporation, and LUMOS SCINTILLATION INC., a New York corporation (each, a “Company”, and collectively, the “Companies”), are each parties to a Security and Pledge Agreement dated as of October 4, 2017 (as heretofore amended, modified or supplemented, the “Security Agreement.” Capitalized terms used and not otherwise defined herein shall have the meanings ascribed to such terms in the Security Agreement.), among the Companies and KEYBANK NATIONAL ASSOCIATION, a national banking association, as Administrative Agent (the “Administrative Agent”), pursuant to which each Company granted a security interest (the “Security Interest”) in all of such Company’s right, title and interest in and to its Collateral, including without limitation the Copyrights and Copyright Licenses, Patents and Patent Licenses, and Trademarks and Trademark Licenses (herein, collectively, the “Proprietary Collateral”) set forth on the attached Schedule A, all to the extent set forth in the Security Agreement; and

WHEREAS, all of the obligations secured by the Security Interest have been fully paid and satisfied and the Administrative Agent desires to release the Security Interest.

NOW THEREFORE, in consideration of the foregoing and intending to be legally bound, the Administrative Agent, without warranty or recourse of any kind; hereby releases its Security Interest held in the Proprietary Collateral listed on Schedule A annexed hereto, and hereby, (i) terminates all its rights, powers, privileges and remedies under the Security Agreement with respect to the Proprietary Collateral, (ii) re-conveys, re-transfers and sets over to the Companies any right, title or interest that the Administrative Agent may have acquired in the Proprietary Collateral, together with all the goodwill associated therewith, and (iii) releases each Company from all covenants, obligations, liabilities and warranties under the Security Agreement related to the Proprietary Collateral.



