applications within the Patent Family, or to carry out the terms of the Assignment, or vest in Assignee its successors and assigns, exclusive title in and to all inventions, patent applications, Patent A, Patent B, the Patent Family, or Trademark assigned hereunder, without further compensation from said Assignee, its successors, legal representatives or assigns, except for reasonable costs and expenses of Assignor incident to such assistance and approved in writing by Assignee, its successors, legal representatives or assigns before any such costs or expenses are incurred;


