TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT (this "Assignment") is made and entered into as of March 19, 2021 ("Effective Date"), by and among Royal Caribbean Cruises Ltd., a stock corporation incorporated under the laws of the Republic of Liberia ("Seller") and the assignors listed on the signature pages hereto (together with Seller, the "Assignors"), and SP Cruises OpCo Limited, an exempted company incorporated under the laws of ("Assignee", and together with Assignors, the "Parties"). Defined terms used but not otherwise defined herein have the meanings set forth in the APA (as defined below).

WHEREAS, Seller and SP Cruises Holdings Limited, an exempted company incorporated under the laws of Bermuda ("Purchaser"), are parties to that certain Acquisition Agreement, dated as of January 18, 2021 ("APA"), pursuant to which Purchaser and/or its Purchaser Designees, including Assignee, are acquiring, among other assets, certain intellectual property of Seller, including the Trademarks set forth on Schedule A attached hereto (the "Transferred Trademarks"); and

WHEREAS, under the terms of the APA, Seller has agreed to execute and deliver this Assignment for recording with the United States Patent and Trademark Office and corresponding entities or agencies in any applicable jurisdictions.

NOW, THEREFORE, the Parties agree for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, as follows:

1. Each Assignor hereby conveys, transfers and assigns to Assignee all of its right, title and interest in and to the Transferred Trademarks, together with (a) any and all claims and causes of action with respect to such Transferred Trademarks, whether accruing before, or after the date hereof, and the right to seek damages for the past, present or future infringement, misappropriation, dilution, or other violation thereof, (b) all rights to proceeds, income, revenues and royalties with respect thereto accruing after the date hereof, and (c) the goodwill of the Business appurtenant to such Transferred Trademarks.

2. This Assignment has been executed and delivered by each Assignor to Assignee for the purpose of recording this Assignment with any applicable governmental authorities, and each Assignor hereby authorizes the Commissioner for Trademarks in the United States Patent and Trademark Office and the officials of corresponding entities or agencies in any applicable jurisdictions to record this Assignment upon request by Assignee.

3. This Assignment may be signed in counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.

4. Each Assignor shall, at Assignee's expense, take all reasonable actions, and provide Assignee, Assignee's successors, assigns or other legal representatives, all such cooperation and assistance (including the execution and delivery of any and all affidavits, declarations, oaths, exhibits, assignments, or other documentation) reasonably requested by Assignee to more fully and effectively effectuate the purposes of this Assignment.

5. This Agreement and any dispute arising out of or relating to or in connection with this Assignment shall be governed by, and construed in accordance with, the Laws of the State of New York. To the fullest extent permitted by applicable Law, each Party hereto (i) agrees that any

claim, action or proceeding by such Party seeking any relief whatsoever arising out of, relating to or in connection with, this Agreement or the transactions contemplated hereby shall be brought only in the United States District Court for the Southern District of New York or in any New York State court, in each case, located in the Borough of Manhattan and not in any other State or Federal court in the United States of America or any court in any other country, (ii) agrees to submit to the exclusive jurisdiction of such courts located in the Borough of Manhattan for purposes of all legal proceedings arising out of, or in connection with, this Agreement or the transactions contemplated hereby, (iii) waives and agrees not to assert any objection that it may now or hereafter have to the laying of the venue of any such Action brought in such a court or any claim that any such Action brought in such a court has been brought in an inconvenient forum, and (iv) agrees that a final judgment in any such action or proceeding shall be conclusive and may be enforced in other jurisdictions by suit on the judgment or in any other manner provided by applicable Law.
