RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST (this “Release”) is given on March 19, 2021, by BANK OF AMERICA, N.A., as Collateral Agent (the “Bank”), to the various owners listed on Schedule A, attached hereto and incorporated herein by this reference, (the “Grantors”).

WHEREAS, the Grantors and the Bank are party to (i) that certain Second Lien Credit Agreement, dated as of August 4, 2017 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Credit Agreement”), by and among the Bank, as administrative agent and collateral agent for the lenders party thereto, the Grantors and other parties party thereto from time to time and (ii) that certain Second Lien Pledge and Security Agreement dated as of August 4, 2017 (the “Collateral Agreement”), by and among the Bank, the Grantors and the other parties party thereto, and the Grantors, as applicable, are party to a Second Lien Trademark Security Agreement dated as of August 4, 2017, a Second Lien Trademark Security Agreement dated as of September 28, 2018 and a Second Lien Trademark Security Agreement Supplement dated as of November 6, 2020 (collectively, the “Trademark Security Agreements”);

WHEREAS, pursuant to the Collateral Agreement and the Trademark Security Agreements, the Grantors granted to the Bank, among other collateral, a continuing security interest in all of the Grantors’ rights, titles and interests, including goodwill, in, to and under the United States Trademarks listed on the attached Schedule A (the “Trademarks”);

WHEREAS, the Trademark Security Agreements were recorded in the United States Patent & Trademark Office on September 07, 2017 at reel/frame 6149/0640, October 1, 2018 at reel/frame 6446/0731 and November 18, 2020 at reel/frame 7109/0235, as applicable;

WHEREAS, the Grantors have performed all of their respective obligations under the Credit Agreement and accordingly the Bank has agreed to terminate and release its security interest in the Trademarks, and retransfer and reassign to the Grantors without recourse all of the Bank’s right, title and interest in and to those Trademarks.

NOW THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank hereby releases any security interest it may have in the Trademarks, and reassigns any and all right, title and interest it may have in and to those Trademarks without recourse to the relevant Grantors.


FURTHERMORE, the Bank hereby authorizes the Grantors and its authorized representatives to record this Release with the United States Patent & Trademark Office and agrees to take all further actions, and provide to the Grantors, all such cooperation and assistance (including without limitation the execution and delivery of any and all documents or other instruments) reasonably requested by the Grantors, at the Grantors’ respective sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

THIS RELEASE AND ANY CLAIM, CONTROVERSY OR DISPUTE ARISING HEREUNDER OR RELATED TO THIS RELEASE, WHETHER IN TORT, CONTRACT (AT LAW OR IN EQUITY) OR OTHERWISE, SHALL BE GOVERNED BY AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK.
