**INTELLECTUAL PROPERTY ASSIGNMENT**

January 19, 2018

**WHEREAS**, Kodiak Products Co., Inc., a Texas corporation (“**Seller**”), is the owner/applicant of all Intellectual Property Assets; and

**WHEREAS**, Dexter Brahma, LLC, a Delaware limited liability company (“**Buyer**”), desires to acquire all domestic and foreign rights, including common law rights, owned by Seller in and to the Intellectual Property Assets and the goodwill symbolized by them, pursuant to the terms of that certain Asset Purchase Agreement by and between Seller and Buyer, dated as of January 19, 2018 (the “**Purchase Agreement**”).

**NOW, THEREFORE**, in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration described in the Purchase Agreement, the receipt and sufficiency of which is hereby acknowledged, Seller and Buyer, do hereby agree as follows:

Seller hereby sells, assigns, transfers and conveys to Buyer all of Seller’s rights, titles and interests in the United States and in all foreign countries, to the extent Seller is the owner of such foreign rights, in and to all intellectual property and industrial property rights and assets, and all rights, interests and protections that are associated with, similar to, or required for the exercise of, any of the foregoing, however arising, pursuant to Law, whether registered or unregistered, including any and all: (a) trademarks, service marks, trade names, brand names, logos, trade dress, design rights and other similar designations of source, sponsorship, association or origin, together with the goodwill connected with the use of and symbolized by, and all registrations, applications and renewals for, any of the foregoing; (b) internet domain names, whether or not trademarks, registered in any top-level domain by any authorized private registrar or Governmental Authority, web addresses, web pages, websites and related content, accounts with Twitter, Facebook and other social media companies and the content found thereon and related thereto, and URLs; (c) works of authorship, expressions, designs and design registrations, whether or not copyrightable, including copyrights, author, performer, moral and neighboring rights, and all registrations, applications for registration and renewals of such copyrights; (d) inventions, discoveries, trade secrets, business and technical information and know-how, databases, data collections and other confidential and proprietary information and all rights therein; (e) patents (including all reissues, divisionals, provisionals, continuations and continuations-in-part, re-examinations, renewals, substitutions and extensions thereof), patent applications, and other patent rights and any other Governmental Authority-issued indicia of invention ownership (including inventor's certificates, petty patents and patent utility models); and (f) software and firmware, including data files, source code, object code, application programming interfaces, architecture, files, records, schematics, computerized databases and other related specifications and documentation (collectively, (“**Intellectual Property**”), in each case that is owned or held for use by Seller and used in or necessary for the conduct of the Business as currently conducted, together with the goodwill of the business symbolized by them, and any and all registrations thereof, as well as all rights to damages or profits, due or accrued, arising out of pastime infringement of any of them or injury to said goodwill and the right to sue for and recover the same in Buyer’s own name. A list of registered Intellectual Property is set forth on Exhibit A hereto.

This instrument may be signed in counterparts each of which shall be deemed an original. The parties further agree that counterparts to this instrument may be delivered by facsimile or pdf.

Capitalized terms used but not defined herein shall have the meanings given to such terms in the Purchase Agreement.


