## TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement is effective as of January 19, 2021.

1. Transfer. Assignor hereby unconditionally and irrevocably assigns, grants, transfers, conveys and delivers exclusively to Assignee, free and clear of any and all liens, encumbrances, and claims of third parties, and Assignee hereby acquires from Assignor ownership and all of Assignor’s right, title, and interest in and to the Fuku Marks, all the goodwill associated and symbolized thereby, the registrations therefor, and the right to claim any applicable priority rights arising from the Fuku Marks, whether registered or unregistered. All rights in or to the Fuku Marks, including, without limitation, the portion of the business to which the Fuku Marks pertains and the right to sue for any damages and other remedies in respect of any infringement of any of the Fuku Marks which may have occurred prior to the date of this Assignment, are hereby assigned and transferred to Assignee and shall be the sole property of Assignee and inure to the benefit of Assignee.
2. Successors and Assigns. This Agreement shall inure to the benefit of and be binding upon Assignor and its respective heirs, successors, licensees and assign.
