## NUNC PRO TUNC TRADEMARK ASSIGNMENT

This Nunc Pro Tunc Trademark Assignment Agreement (“Assignment”) is made effective as of December 31, 2020 (“Effective Date”) by and between Alliance Healthcare Services, Inc., a Delaware corporation (“Assignor”), and TPC Partners, LLC, an Arizona limited liability company, located at 5281 North 99th Avenue, Suite 100, Glendale, Arizona 85305 (“Assignee”), each a “Party” and collectively, the “Parties.”

WHEREAS, Assignor is the owner of U.S. Trademark Registration No. 5,315,501 for the trademark  **ThePainCenter** in the U.S. Patent and Trademark Office (the “TPC Mark”);

WHEREAS, Assignee desires to obtain all of Assignor’s right, title and interest in, to and under the TPC Mark; and

WHEREAS, Assignor has agreed to convey, transfer, assign and deliver to Assignee, and Assignee has agreed to accept, all of its right, title and interest in, to and under the TPC Mark.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

1. Assignor does hereby convey, transfer, assign and deliver unto Assignee, its full and entire right, title and interest in, to and under the TPC Mark, which shall include, without limitation, all rights that may now or hereafter be vested in or controlled by Assignor, together with the goodwill connected with the foregoing; and all benefits, privileges, causes of action and remedies relating to any of the foregoing, whether before or hereafter accrued (including, without limitation, the exclusive rights to apply for and maintain all applications, registrations, renewals and/or extensions; to sue for all past, present or future infringements or other violations of any rights in the TPC Mark, and to settle and retain proceeds from any such actions); and any and all of Assignor’s other rights, title and interest in and to the foregoing, the same to vest in Assignee as of the Effective Date.
2. This Assignment shall be binding upon and shall inure to the benefit of Assignor and Assignee and their respective successors, assigns, and heirs.
3. This Assignment may be executed in two or more counterparts, each of which shall be deemed to be an original and all of which shall constitute the same agreement.
