WHEREAS, pursuant to the Security Agreement, Company conveyed to Bank a security interest in the trademarks listed in Schedule A (the "Trademarks");


WHEREAS, Company has satisfied its obligations under the Security Agreement, and Bank desires to release its security interest in the Trademarks as provided in the Security Agreement;
