ASSIGNMENT OF INTELLECTUAL PROPERTY

WHEREAS, SEATEK COMPANY INCORPORATED, a corporation organized and existing under the laws of the state of Connecticut, with its head offices at 392 Pacific Street, Stamford, Connecticut, 06902 (the "*Assignor*"), is the owner of all right, title and interest in and to certain trademarks, trade names and intellectual property registrations identified on Exhibit A, and rights related thereto (the "*Intellectual Property*") for certain goods and services that are Purchased Assets for purposes of that certain Asset Purchase Agreement dated as of even date herewith by and between, among others, the parties hereto (the "*Asset Purchase Agreement*").

WHEREAS, SOUTHWIRE COMPANY, LLC, a limited liability company organized and existing under the laws of the state of Delaware, with its head offices at One Southwire Drive, Carrollton, Georgia, 30119 (the "*Assignee*"), desires to acquire the Intellectual Property.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignor hereby assigns to the Assignee all of the Assignor's right, title and interest in and to the Intellectual Property, together with Assignor's common law rights in the Intellectual Property, all goodwill of the business symbolized by and associated with the Intellectual Property, all income, royalties, damages and payments now or hereafter due or payable with respect to the Intellectual Property, the right to register the Intellectual Property, the right to renew or transfer any registration of the Intellectual Property, all rights of action arising from the Intellectual Property, including all claims for damages by reason of past, present and future infringement of the Intellectual Property and the right to sue and collect damages for such infringement, to be held and enjoyed by Assignee for its own use and benefit and for its successors and assigns as the same would have been held by the Assignor had this assignment not been made.

The Assignor agrees to cooperate with the Assignee by executing and delivering any documents that may be reasonably necessary to complete and effectuate the transfer to the Assignee of the Assignor's right, title, and interest in and to the Intellectual Property and by filing trade name withdrawal documents with the Connecticut Secretary of State upon Assignee's request and expense.

This Assignment of Intellectual Property shall be governed by and construed in accordance with the laws of the State of Delaware, without regard to conflict of laws principles.
