ARTICLE TWO. The name of the surviving business entity is "De Wafelbakkers Acquisition, LLC."

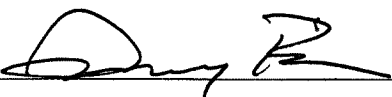

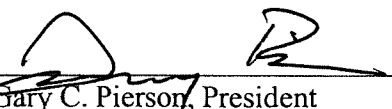

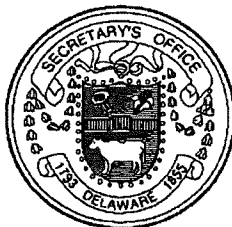
