TRADEMARK SECURITY AGREEMENT
[OVERLINE CAPITAL LLC]

THIS TRADEMARK SECURITY AGREEMENT (this "Agreement"), dated as of March 30, 2021 by OVERLINE CAPITAL LLC, a Delaware limited liability company (the "Grantor"), in favor of SYNOVUS BANK (the "Lender").

RECITALS

A. The Grantor, HOLLYWOOD.COM HOLDINGS, LLC, a Delaware limited liability company, R&S INVESTMENTS, LLC, a Delaware limited liability company, MITCHELL RUBENSTEIN and LAURIE S. SILVERS (individually and/or collectively, the "Borrower") have entered into that certain Loan Agreement dated as of even date herewith (as may be amended, restated, supplemented or otherwise modified from time to time, the "Loan Agreement") with the Lender, pursuant to which the Lender has agreed to make a loan to Borrower.

B. In connection therewith, Grantor and Lender are entering into this Agreement to secure the payment of all amounts owing by the Borrower under the Note, the Loan Agreement and the other Loan Documents, including, without limitation, any Swap Transaction Documents.

In consideration of the mutual agreements set forth herein and in the Loan Agreement, the Grantor does hereby grant to the Lender, a continuing security interest in all of Grantor's right, title and interest in, to and under the following, whether presently existing or hereafter created or acquired:

- (1) each trademark and trademark application, including, without limitation, each trademark and trademark application referred to in Schedule 1 attached hereto, together with any reissues, continuations or extensions thereof and all goodwill associated therewith;
- (2) each trademark license, including, without limitation, each trademark license listed on Schedule 1 attached hereto, together with all goodwill associated therewith; and
- (3) all products and proceeds of the foregoing, including, without limitation, any claim by the Grantor against third parties for past, present or future infringement of any trademark, including, without limitation, any trademark referred to in Schedule 1 attached hereto, any trademark issued pursuant to a trademark application referred to in Schedule 1 and any trademark licensed under any trademark license listed on Schedule 1 attached hereto (items 1 through 3 being herein collectively referred to as the "Trademark Collateral").

The Grantor hereby acknowledges and affirms that the rights and remedies of the Lender with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Loan Documents, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. Capitalized terms used but not defined herein have the respective meanings ascribed thereto in the Loan Agreement.

Notwithstanding anything to the contrary contained in any of the Loan Documents, Lender shall not disturb the rights of any future third party seeking an interest in the Trademark Collateral for purposes of producing, distributing, licensing and/or financing said Trademark Collateral for film, television, video or digital production and/or distribution, so long as the third party is not in material breach of its obligations to Grantor. Upon Grantor's request with respect to a particular third party, Lender will negotiate, execute and deliver (i) a non-disturbance agreement with the third party, in form reasonably acceptable to the Lender, Grantor and the third party, or (ii) if required by the third party, a partial release of this Agreement (together with any related UCC-1 financing statement and any trademark security agreement recorded with the United States Patent and Trademark Office) with respect to the applicable Trademark Collateral

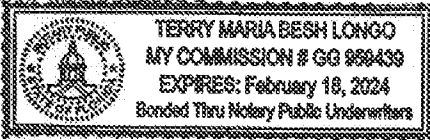

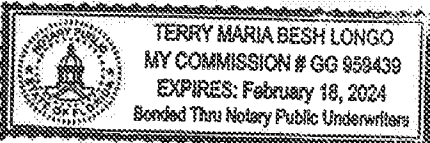
