WHEREAS by agreement which came into effect on February 1st, 2021, Assignor has assigned to Assignee the ownership of the Trademarks.

WHEREAS the purpose of the present deed is to confirm this transfer of ownership in order to proceed with its recordal before the concerned trademark offices and authorities.

AND WHEREAS, Assignee, by way of the Agreement effective February 1, 2021, is the successor to the business and the assets of Assignor to which the mark pertains.

THE FOLLOWING HAS BEEN AGREED UPON:

1. The Assignor hereby confirms the transfer of ownership to the Assignee, who accepts, of all its rights of ownership and use to the Trademarks with respect to all goods and services for which the Trademarks are registered and its attached goodwill without any restriction or reserve.
2. The Assignor shall execute any further documents and comply with any further transfer proceedings as the Assignee may require to enable the Assignee to become registered as proprietor of the Trademarks and to secure the benefit of the rights hereby assigned.
3. The Assignor hereby warrants that it is the proprietor of the Trademarks and has the full power to enter into this agreement.
