TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

This Termination and Release of Intellectual Property Security Agreement (this “Release”) is made with regard to that certain Intellectual Property Security Agreement dated as of March 30, 2018 (as amended, restated, supplemented or otherwise modified and in effect from time to time, the “IP Agreement”) by and among HERCULES CAPITAL, INC., a Maryland corporation (the “Agent”), INSURANCE TECHNOLOGIES CORPORATION, a Texas corporation (“Insurance Technologies Corporation”), ASSURANCE SYSTEMS, INC., a Georgia corporation (“Assurance Systems” together with Insurance Technologies Corporation, collectively, the “Grantors”). Capitalized terms used but not otherwise defined herein shall have the meanings set forth in the IP Agreement.

Reference is made to that certain Revolving Credit, Term Loan and Security Agreement, dated as of March 28, 2018 (as amended, restated, supplemented or otherwise modified and in effect from time to time, the “Credit Agreement”), among ITC Intermediate Holdings, Inc., a Delaware corporation (“Holdings”), Insurance Technologies Corporation (together with Holdings, the “Borrowers”), the guarantors from time to time party thereto (the “Guarantors”, and collectively with the Borrowers, the “Loan Parties”), the Agent, the other banks, financial institutions and other entities from time to time parties thereto as Lenders (such lenders, together with their respective successors and permitted assigns, each a “Lender” and collectively, the “Lenders”).

WHEREAS, pursuant to the IP Agreement, which was recorded in the U.S. Patent and Trademark Office at Reel/Frames 046432/0436 and 6307/0370, Insurance Technologies Corporation granted to the Agent a security interest in certain Registered Intellectual Property, listed in Schedule I hereto;

WHEREAS, pursuant to the Supplement to IP Agreement dated as of November 1, 2018 (the “Supplement No. 1”), which was recorded in the U.S. Patent and Trademark Office at Reel/Frame 6307/0370, Assurance Systems granted to the Agent a security interest in certain Registered Intellectual Property, listed in Schedule II hereto;

WHEREAS, pursuant to the Supplement No. 2 to IP Agreement dated as of August 13, 2019 (the “Supplement No. 2”), which was recorded in the U.S. Patent and Trademark Office at Reel/Frame 6846/0666, Insurance Technologies Corporation granted to the Agent a security interest in certain Registered Intellectual Property, listed in Schedule III hereto;

WHEREAS, pursuant to the Supplement No. 3 to IP Agreement dated as of January 31, 2020 (the “Supplement No. 3”), which was recorded in the U.S. Patent and Trademark Office at Reel/Frame 6853/0447, Insurance Technologies Corporation granted to the Agent a security interest in certain Registered Intellectual Property, listed in Schedule IV hereto;

WHEREAS, the Grantors have paid and satisfied in full their Obligations under the Credit Agreement, and the parties desire to enter into this Release to confirm that the Agent has released its security interests in and to the Registered Intellectual Property and to expunge any recordation of the security interest insofar as it pertains to the Registered Intellectual Property.

NOW, THEREFORE, for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent forever releases and discharges the entire security interest in and to all of the Registered Intellectual Property, including the trademarks, trademark applications, patents, patent applications and copyrights, granted to the Agent by the IP Agreement, Supplement No. 1, Supplement No. 2 and Supplement No. 3.

The Agent hereby agrees to execute such instruments, to take such other actions, and to give such further assurances as the Grantors reasonably shall request to terminate any security interest in the Registered Intellectual Property pursuant to the IP Agreement and otherwise to effectuate the release of all recordations of such security interest in the Registered Intellectual Property.

The Agent acknowledges and agrees that the Grantors and its successors and assigns may rely upon this Release. The Agent represents and warrants that it has not transferred or assigned all or any part of the security interest in the Registered Intellectual Property to any third party, and that it has all necessary authority to execute this Release and grant the releases and discharges and all other rights set forth herein.
