TRADEMARK ASSIGNMENT

WHEREAS, Demag Cranes & Components GmbH, a corporation organized and existing under the laws of Germany, having its principal place of business at Forststraße 16, 40597 Düsseldorf, Germany (hereinafter referred to as "Assignor"), is the owner of all right, title and interest to the trademark VISUMATIC ("Mark"), registered in the United States Patent and Trademark Office on June 11, 2002, as Reg. No. 2,579,328.

NOW, THEREFORE, in consideration of the sum of one dollar (\$1.00), and for other good and valuable considerations, the receipt of which is hereby acknowledged, said Assignor does sell, assign, transfer, convey, and set over to Assignee the entire right, title, and interest in and to the aforesaid Mark that Assignor may possess, together with the goodwill of the business symbolized by said Mark and trademark registration, and including the right to sue for and collect for past infringement thereof for the full term or terms of all such rights, together with its right to recover on all claims for lost profits and damages for any and all past infringement thereof, as well as all rights under any causes of action having accrued heretofore in the United States with respect to said Mark.

FURTHER, Assignor represents, warrants and agrees that upon the reasonable request of Assignee, Assignor shall execute and deliver any further instruments or documents and take all such further action, or cause any affiliate of Assignor to do the same, to perfect Assignee's right, title and interest in said Mark assigned by this Agreement, and agrees to communicate to said Assignee or its representatives any facts known to Assignor respecting said Mark and its use to obtain and enforce proper protection for said Mark in the United States.
