To the extent that following the release set forth in this paragraph, the Secured Party retains or would retain any right, title or interest in or to the Intellectual Property Collateral, the Secured Party hereby reassigns, grants and conveys to the Grantors such Grantor's right, title and interest in, to and under the Intellectual Property Collateral.
