RELEASE OF IP SECURITY INTEREST


This Release of Security Interest is made as of March __, 2021, by Gores Small Cap Tech Investors, LLC, a Delaware limited liability company (“Lender”) in favor of Astadia, Inc., a Delaware corporation (“Grantor”).

Grantor granted to Lighthouse Capital Partners VI, L.P. (“Lighthouse”) a security interest in certain intellectual property, including without limitation, the trademarks listed on Exhibit A hereto, (collectively, the “Intellectual Property”), under an Intellectual Property Security Agreement dated April 30, 2010 (the “Security Agreement”).
