## ASSIGNMENT AGREEMENT

This Assignment Agreement (the "**Agreement**") is entered into on January 15, 2021 (the "**Effective Date**") by and between:

**Laboratorios Pisa, S.A. de C.V. ("PISA" and/or "Assignor")**, a corporation organized and existing under the laws of the Country of Mexico, and having its principal offices and headquarters at Av. España 1840, Colonia Moderna, Zip Code 44190, in Guadalajara, Jalisco, México;

and

**Sueros y Bebidas Rehidratantes, S.A. de C.V. ("Sueros y Bebidas" and/or "Assignee")**, a corporation organized and existing under the laws of the Country of Mexico, having its principal offices and headquarters at Av. España 1840, Colonia Moderna, Zip Code 44190, in Guadalajara, Jalisco, México.

**PISA** and **Sueros y Bebidas** shall individually be referred to as the "**Party**" and together as the "**Parties**".

WHEREAS, **PISA** has in connection with its goods and services adopted, used or had bona fide intent to use, and is the owner of the entire rights, title, and interest in and to the Trademark Applications and Registrations filed before the United States Patent and Trademark Office (the "**Trademarks**"), including associated good will, which it uses in its business, as designated under Schedule A attached hereto.

WHEREAS, **Sueros y Bebidas** desires to obtain the entire rights, title, and interest in and to the aforesaid Trademarks, and in and to the good will of the business in connection with said Trademarks;

NOW, THEREFORE, for and in consideration of the mutual covenants and premises, the Parties agree as follows:

1. For and in consideration of the sum of one U.S. dollar (\$1.00 only), and other good and valuable consideration, paid by **Sueros y Bebidas**, the receipt of which is hereby acknowledged, **PISA** by the present Agreement does hereby sell, transfer, assign and convey onto **Sueros y Bebidas**, its legal representatives, successors, and assigns: a) all rights, title, and interests derived from and in connection with the Trademarks; b) together with the goodwill of the business relating to the products and services on which the marks are used and for which they are registered and symbolized by the Trademarks; c) and together with all claims for damages by reason of past or future infringement or unfair competition of or in connection with any said Trademarks, including all rights for **Sueros y Bebidas** to sue, claim and/or defend the Trademarks accordingly.
  
2. **PISA** represents and warrants that it is the sole proprietor of all rights, title and interests derived from the Trademarks, and that the assignment of the Trademarks from **PISA** to **Sueros y Bebidas** shall not cause any infringement of intellectual property rights of any third party in the United States of America. The Trademarks are assigned in their present legal status. To **PISA's** knowledge, there are no parties that are using the Trademarks, own registrations or pending applications for registration of the Trademarks, and there are no cases which may adversely affect the Trademarks.


