## **TRADEMARK RELEASE AND REASSIGNMENT**

THIS TRADEMARK RELEASE AND REASSIGNMENT (“Release”) is made as of April 1, 2021, by GOLUB CAPITAL LLC, as collateral agent (the “Collateral Agent”), in favor of RESTORIX, LLC (“Grantor”). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

### WITNESSETH:

WHEREAS, Grantor and Collateral Agent are parties to that certain Trademark Security Agreement dated as of September 1, 2015 (the “Security Agreement”) pursuant to which Grantor granted a security interest to Collateral Agent in certain Trademark Collateral (as defined therein) as security for certain obligations owing by Grantor to Collateral Agent, including the Trademark Collateral set forth on Schedule A hereto;

WHEREAS, the Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on September 1, 2015, at Reel 005612, Frame 0805;

WHEREAS, Grantor has requested that Collateral Agent release its security interest in the Trademark Collateral and reassign any and all rights in the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Collateral Agent hereby releases, relinquishes, terminates in its entirety and discharges fully its security interest in all of Grantor’s right, title and interest in, to and under all of Grantor’s presently existing or hereafter acquired right, title and interest in and to the Trademarks, including, without limitation, the Trademarks set forth on Schedule A hereto, all proceeds and products thereof and all goodwill associated with or symbolized by any of the foregoing, but excluding any Trademarks that constitute Excluded Property (as defined in the Security Agreement).


