**TERMINATION AND RELEASE OF SECURITY INTEREST IN  
INTELLECTUAL PROPERTY**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**, dated as of March 31, 2021 (“Release”), is made by CREDIT SUISSE AG, CAYMAN ISLANDS, as collateral agent for the Secured Parties (the “Collateral Agent”), in favor of TOTAL RECALL CORPORATION, a New York corporation, INTEGRATED SECURITY SYSTEMS INC., a Florida corporation and CONVERGINT TECHNOLOGIES LLC, a Delaware limited liability company (each a “Grantor” and collectively, the “Grantors”). Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the IP Security Agreement, whether directly or by reference.

**WHEREAS**, pursuant to (i) that certain Guarantee and Collateral Agreement dated as of February 1, 2018 (as the same may have been amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the “Security Agreement”) by and among, inter alios, the Collateral Agent and the Grantors and (ii) that certain Intellectual Property Security Agreement dated as of February 1, 2018 (the “IP Security Agreement”), by and between the Collateral Agent and the Grantors, each Grantor granted to Collateral Agent a security interest (the “Security Interest”) in all of such Grantor’s right, title and interest in, its Intellectual Property (including without limitation those Copyrights, Patents and Trademarks listed on Annex I hereto) and all proceeds thereof (such as, by way of example but not by way of limitation, license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements, all rights corresponding thereto throughout the world and all re-issues, divisions continuations, renewals, extensions and continuations-in-part thereof (collectively, the “Intellectual Property Collateral”);

**WHEREAS**, the Intellectual Property Security Agreement was recorded with the Patent division of the United States Patent and Trademark Office on February 9, 2018 at Reel/Frame 045298/0001, in the Trademark division of the United States Patent and Trademark Office on February 9, 2018 at Reel/Frame 6270/0504, and in the United States Copyright Office on February 9, 2018 at Volume 9954 Document 883; and

**WHEREAS**, the Collateral Agent now desires to terminate the IP Security Agreement and release and restore all right, title and interest in and to the Intellectual Property Collateral to the Grantors and to dissolve those liens and encumbrances created by the IP Security Agreement in respect of the Intellectual Property Collateral under the IP Security Agreement.

**NOW THEREFORE**, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Collateral Agent hereby terminates the IP Security Agreement and hereby cancels, discharges, and releases the Security Interest in the Intellectual Property Collateral.

Each Grantor (and any person or entity hereafter holding any right, title or interest in the Intellectual Property Collateral of such Grantor) is hereby authorized to record this Release with respect to the Intellectual Property Collateral of such Grantor, at Grantor’s or such person’s or entity’s expense.
