**TRADEMARK RELEASE AND REASSIGNMENT**

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of April 1, 2021 by MARANON CAPITAL, L.P., as Agent for the Lenders (in each case, as defined in the Trademark Security Agreement referred to below).

**WITNESSETH:**

WHEREAS, Agent and Wedgewood Village Pharmacy, LLC, a Delaware limited liability company (“**Grantor**”), were parties to that certain Trademark Security Agreement dated as of July 17, 2018 (the “**Security Agreement**” capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Security Agreement), and that certain Guarantee and Collateral Agreement, dated as of July 17, 2018, pursuant to which Grantor granted a security interest to Agent in the Trademark Collateral (as defined below) as security for certain obligations owing by Grantor to Agent, including the Trademarks set forth on **Schedule I** hereto; and

WHEREAS, the Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on July 19, 2018, at Reel 6412, Frame 0377; and

WHEREAS, Grantor has requested that Agent release its security interest in and lien on all of Grantor’s right, title and interest in, to and under the Trademark Collateral and reassign the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases its continuing first priority security interest in all of Grantor’s right, title and interest in, to and under the following, whether presently existing or hereafter created or acquired (collectively, the “Trademark Collateral”):

(a) each Trademark listed on **Schedule 1** annexed hereto, together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark; and

(b) all products and proceeds of the forgoing, including without limitation, any claim by Grantor against third parties for past, present or future (a) infringement or dilution of any Trademark, or (b) injury to the goodwill associated with any Trademark.

2. Agent hereby reassigns, grants and conveys to Grantor, without any representation, warranty, recourse or undertaking by Agent, all of Agent's right, title and interest in and to the Trademark Collateral.

3. Agent hereby further authorizes and consents that this release may be recorded and indexed by the Commissioner of Patents and Trademarks of the United States Patent and Trademark Office.
