**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Release”) is made as of March 31, 2021, by **CITIBANK, N.A.**, a national banking association, (“Citibank”) in favor of **CALPINE CONTAINERS, INC.**, a California corporation (the “Grantor”).

W I T N E S S E T H:

WHEREAS, the Grantor entered into that certain Security Agreement (Trademarks) with Citibank dated August 10, 2015 (the “Trademark Security Agreement”), pursuant to that certain Loan and Security Agreement dated August 10, 2015 (as amended, modified, supplemented or extended from time to time, the “Loan Agreement”), by and among the Grantor (identified as the “Borrower” therein and together with each person thereafter party thereto as a borrower, collectively, the “Borrowers”), each of the financial institutions identified as a “Lender” on Annex A attached thereto (together with each of its respective successors and assigns, each a “Lender” and, collectively, the “Lenders”) and Citibank, acting not individually but as an agent on behalf of, and for the benefit of, the Lenders and all other Secured Parties (Citibank, when acting in such agency capacity, the “Agent”), notice of which was recorded on August 11, 2015 at the United States Patent and Trademark Office at Reel 5597, Frame 0753.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, Grantor granted the Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Agent, in and to all of its right, title and interest in and to its Property, including the Trademarks listed in Schedule A hereto, and all goodwill of such Grantor’s business symbolized by the Trademarks and associated therewith.

WHEREAS, the Agent has agreed to irrevocably terminate and release its Security Interest in all such Property as herein provided.


NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Agent hereby (1) irrevocably releases, terminates and discharges any and all of its interest in the Property of the Grantor, including the goodwill of such Grantor’s business symbolized by the Trademarks; (2) to the extent the Agent retains any interest in the Property, the Agent hereby assigns, transfers and conveys to Grantor the Security Interest in and to the Property to the Grantor; and (3) the Agent hereby agrees to promptly execute, acknowledge and deliver all such further instruments and to take all such further actions as may be reasonably requested or are required in order to more fully and effectively carry out the purposes of this release at the Grantor’s sole cost and expense.
