This Agreement is made on 6 August 2019

Between:

Parties

- (1) **Karen Millen Fashions Limited (in administration)** (company number 06822177) whose registered office is at The Triangle, Stanton Harcourt Industrial Estate, Stanton, Harcourt, Witney, Oxfordshire, OX29 5UT acting by the Administrators;
- (2) **Karen Millen Retail Limited (in administration)** (company number 06822157) whose registered office is at The Triangle Stanton Harcourt Industrial Estate, Stanton Harcourt, Witney, Oxfordshire, OX29 5UT acting by the Administrators;

(each, an “Assignor”, and together, the “Assignors”); and

- (3) **Robert James Harding and Richard Michael Hawes** of Deloitte LLP, 1 New Street Square, London EC4A 3HQ (the “Joint Administrators”); and
- (4) **KarenMillen.com Limited (in the process of being changed from Aghoco 1846 Limited)** (company number 12054246) whose registered office is at 49-51 Dale Street, Manchester, United Kingdom, M1 2HF (the “Assignee”);

(each, a “Party”, and together, the “Parties”).

Whereas:

- (A) The Administrators (as defined below) were appointed joint administrators of the Assignors on the date of this Agreement pursuant to paragraph 14 of Schedule B1 to the Insolvency Act 1986.
- (B) By the KM Purchase Agreement (as defined below), each of the Assignors (acting by the Administrators) has agreed to assign to the Assignee such right, title and interest in and to the Trade Marks (as defined below) as each Assignor may have, and the Assignee has agreed to accept such assignment, on the terms set out in this Agreement.
- (C) The Administrators have entered into this Agreement for the purpose of obtaining the benefit of the provisions in their favour and shall incur no personal liability of any kind under or in connection with this Agreement.

Pursuant to and for the consideration set out in the KM Purchase Agreement, and for and in consideration of the mutual promises and obligations set out in this Agreement, **it is agreed:**

1. Definitions and Interpretation

1.1 In this Agreement, the following expressions have the following meanings:

“Act” has the meaning given to it in Clause 13;

“Administrators” means the Joint Administrators as administrators of the Assignors or as subsequently appointed liquidators pursuant to the provisions of the Insolvency Act 1986;

“Completion” has the meaning given to it in the KM Purchase Agreement;

“Completion Date” means the date of the KM Purchase Agreement;

“Indemnified Parties” has the meaning given to it in Clause 8.10;

“KM Purchase Agreement” means the agreement for the sale and purchase of certain of the assets of the Assignors relating to the Karen Millen brand, entered into on the date of this

Agreement between (1) the Assignors; (2) the Administrators; (3) the Assignee; and (4) Boohoo.com UK Limited;

“**Trade Marks**” means (a) the registered trade marks and applications for registration of trade marks listed in **Schedule 1** (Trade Marks); (b) all registered trade marks and service marks, applications for registration of trade marks and service marks, and unregistered trade marks and service marks relating to the Karen Millen brand and owned by any of the Assignors at the date of the KM Purchase Agreement; and (c) all rights in goodwill attached to any of the items referred to under (a) or (b); and

“**Trading Period**” has the meaning given to it in the KM Purchase Agreement.

1.2 The following rules of interpretation apply in this Agreement:

- (a) the singular includes the plural and vice versa and reference to any gender includes the other genders;
- (b) a “person” includes any individual, partnership, firm, bodies corporate, unincorporated associations, wherever incorporated or situate, and includes a reference to that person’s legal representatives and successors;
- (c) words and phrases defined in the Companies Act 2006 or the Insolvency Act 1986 have the same meanings in this Agreement;
- (d) a “**Clause**” or a “**Schedule**” is a reference to a clause of or schedule to this Agreement, and references within a Schedule to “paragraphs” are to paragraphs or sub paragraphs of that Schedule (unless the context states otherwise);
- (e) except as expressly set out in this Agreement, any lists contained in any Schedule are for guidance only and shall not constitute any warranty in respect of the Assignors’ ownership of the listed items or the state, quality and fitness purpose of the listed items or otherwise; and
- (f) the Administrators shall be construed as being the Administrators both jointly and severally and to any other person who is appointed as an administrator in substitution for any administrator or as an additional administrator in conjunction with the Administrators.

1.3 Where the words “include(s)”, “including” or “in particular” are used in this Agreement, they are deemed to have the words “without limitation” following them.

1.4 Any reference to any statute or statutory instrument, or any section or part thereof, includes any enactment that has replaced or amended it or any instrument, order or regulation made under it that is now in force and also includes any past statutory provisions which such provision has directly or indirectly replaced.

1.5 Headings are for reference purposes only and shall not affect the construction of anything in this Agreement.

1.6 The Schedules shall be treated as an integral part of this Agreement and references to this Agreement shall include the Schedules.

2. Assignment

Pursuant to the KM Purchase Agreement, and subject to the retention of the rights granted under the license provided for in Clause 7, each of the Assignors hereby absolutely and irrevocably assigns to the Assignee, and the Assignee hereby accepts the assignment of, all of the relevant Assignor's right, title and interest in and to the Trade Marks, including:

- (a) all statutory and common law rights attaching to the Trade Marks;
- (b) the absolute entitlement to any registrations granted pursuant to any of the applications comprised in the Trade Marks;
- (c) the right to file any applications based on any of the Trade Marks; and
- (d) any and all rights arising from ownership of any of the Trade Marks, including all rights to bring, make, oppose, defend and appeal proceedings, claims or actions, and to recover and retain damages in respect of any infringement, or any other cause of action arising from ownership, of the Trade Marks, but in each case only to the extent occurring after the date of this Agreement.

3. Recordal of the Assignment

Except to the extent prohibited or required otherwise by applicable law, the Assignee shall be solely responsible, at its own cost and expense, for all recordals of the assignments made under this Agreement, including all filings and other actions required to make such recordals, and all costs and expenses incurred in connection therewith, including filing and counsel fees.

4. Further Assurance

Each of the Assignors (for so long as the Administrators, including any subsequent liquidators, remain in office) and the Administrators (for so long as the Joint Administrators remain in office) shall, at the Assignee's written request and expense, do, execute and deliver (or procure to be done, executed and delivered) all such further acts, documents and things reasonably required by the Assignee in order to give full effect to this Agreement, including for assisting the Assignee with the recordal of the assignment of the Trade Marks assigned by the relevant Assignor under this Agreement, but in each case only to the extent that such acts, documents or things cannot be done or executed by the Assignee or, if they can be done or executed by the Assignee, to the extent they would not be sufficient to achieve the purposes of giving full effect to this Agreement, including the recordal of the assignments of the Trade Marks assigned by the relevant Assignor under this Agreement.

5. Confirmatory Assignment

If in any country or territory the execution after the date of this Agreement of a confirmatory assignment or other document of any of the Trade Marks in that country or territory would be ineffective or invalid by reason of the transfer effected by this Agreement, then this Agreement shall be deemed to be an agreement to assign, and not an assignment of the relevant Trade Marks in that country or territory. This shall not create any obligation of any of the Assignors or any of the Administrators beyond the obligations under Clause 4 or, in respect of the Administrators, beyond the point in time when the Joint Administrators have ceased to be in office, or in respect of the Assignors, beyond the point in time when the Administrators, including any subsequent liquidators, have ceased to be in office.

6. Representations and Warranties

All warranties, representations, conditions and other terms implied by statute, at common law, on the basis of usage, custom or the Parties' previous course of dealings, in fact or otherwise, are hereby excluded to the fullest extent permitted by law.

7. Licence-back

Upon signing of this Agreement, each of the Assignors and the Assignee shall deliver to the other Party an executed counterpart to the licence agreement by and between the Assignee (as licensor) and the Assignors (each as a licensee) regarding the Trade Marks in the form attached hereto as **Schedule 2** (Form of Trade Marks Licence-back Agreement).

8. Exclusion of Administrators' Personal Liability etc.

- 8.1 The Administrators enter into this Agreement as agents of each of the Assignors and without personal liability (whether arising under the Insolvency Act 1986 or otherwise) and join in this Agreement in their personal capacities for the purpose of receiving the benefit of the exclusions of liability and acknowledgements in their favour contained in this Agreement.
- 8.2 The Assignee acknowledges that it places and has placed no reliance whatsoever on any representations, agreements, statements or undertakings (oral or in writing) made or alleged to have been made by the Administrators or any member of the Administrators' firm or the Administrators' Solicitors or any agents or advisers of the Administrators, in relation to the Trade Marks.
- 8.3 The Schedules have been populated based on the Assignors' and the Administrators' understanding of the position as at Completion. If any error, misstatement or omission is discovered in relation to the Schedules, the same shall not annul the assignment nor shall the Assignee be entitled to compensation in any circumstances whatsoever.
- 8.4 All conditions, warranties and liabilities on the part of the Administrators and the Assignors, whether express or implied by statute or otherwise, as to any Trade Mark and in particular (without limitation) warranties as to title, quiet possession, satisfactory quality, fitness for any purpose and correspondence with any description are excluded.
- 8.5 The interest that each of the Assignors assigns and the Assignee receives in each Trade Mark is only such right, title or interest (if any) as the relevant Assignor has and references in this Agreement to any Trade Mark shall mean only such right, title or interest.
- 8.6 The Assignee acknowledges that any reference to any Trade Mark in this Agreement or in any document provided by the Assignors or the Administrators is for the purposes of identification only and does not constitute a description thereof on which the Assignee may rely and that the Assignee has made its own assessment of the Trade Marks, their state and condition, whereabouts, fitness for any purpose and value and in doing so has placed no reliance upon and shall have no right of action in respect of, any statement (express or implied) or document given by, or any silence of, the Assignors, the Administrators or any of their respective servants, agents, solicitors, valuers or advisers in relation to any matter affecting the Assignors, the Trade Marks or any of them and neither the Assignors nor the Administrators shall incur any liability to it by reason of any fault or defect in all or any of the Trade Marks or any breach of the obligations of the Assignors arising under the Sale of Goods Act 1979.
- 8.7 The exclusions of liability, acknowledgements and waivers in this Clause 8 shall have effect, and shall continue to have effect, whether the Administrators' capacity as agents of the Assignors continues or has been terminated prior to signing this Agreement or is terminated at

any time thereafter. Such exclusions, acknowledgements and waivers shall continue notwithstanding the Completion Date and shall be in addition to, and not qualified by or in substitution for, any right of indemnity, recovery or relief otherwise available to the Administrators and shall apply to claims formed in contract, tort or otherwise howsoever.

- 8.8 Save for any liability arising as a result of a breach by the Assignors of their respective obligations under Clause 4, the Administrators shall be under no obligation to treat any liability of any of the Assignors arising pursuant to or in relation to this Agreement (whether to any Party to this Agreement or otherwise) as a liability falling within the provisions of paragraph 99 of Schedule B1 to the Insolvency Act 1986 or rule 3.50 of the Insolvency (England and Wales) Rules 2016 and the Assignee renounces any such recourse against the Assignors and/or the Administrators.
- 8.9 The Assignee acknowledges that the terms, conditions and exclusions of this Agreement are fair and reasonable in the circumstances of the Assignors' insolvencies, and are in accordance with normal practice in relation to sales by companies in administration in particular by reason that:
- (a) the Assignee has, as it acknowledges, been given every reasonable opportunity to inspect and investigate the Trade Marks and is aware of the need to rely on such inspection and investigation in the absence of warranties;
 - (b) the terms upon which the Assignors are able and willing to deal are substantially constrained by their insolvent state;
 - (c) the Administrators have available to them only limited knowledge in relation to the Assignors and their affairs;
 - (d) the Assignors and the Administrators have specifically told the Assignee that the Assignee must rely absolutely on the Assignee's own opinion and/or professional advice concerning:
 - (i) the terms of this Agreement;
 - (ii) the quality, state and condition of the Trade Marks, their fitness and/or suitability for any purpose and the possibility that some or all of them may have defects not apparent on inspection and examination; and
 - (iii) the possibility that the Assignee may not acquire title to all or any of the Trade Marks together with the fact that the Assignee would have no remedy under this Agreement should that happen.
- 8.10 The Assignee covenants with each of the Assignors, each of the Administrators and each of their respective estates, servants, agents and advisers ("**Indemnified Parties**") to keep the Indemnified Parties and each of them fully and effectively indemnified from and against all actions, proceedings, claims, demands, liabilities, costs and expenses of any kind, whatsoever and howsoever arising, whether directly or indirectly in relation to the Assignee's compliance with the provisions of this Agreement.
- 8.11 Where any indemnity is given in this Agreement by the Assignee to the Administrators, the Assignors or any other person, such indemnity shall be limited and apply only to the extent which if payable by the Assignors would be an expense of the administration of the Assignors in accordance with paragraph 99 of Schedule B1 of the Insolvency Act 1986 or Rule 3.50 of the Insolvency Rules 1986 or as a personal liability of the Administrators.
- 8.12 The Assignee acknowledges that it has, and has informed the Assignors and the Administrators that it has available to it (either internally or externally) skilled professional advice concerning the matters referred to in this Agreement and on that basis the Assignee has

agreed to purchase and be assigned the Trade Marks for a consideration calculated to take into account the risk to the Assignee represented by the fact that all the Parties believe that the said exclusions and limitations would be recognised as fully effective by the courts, the Assignors and the Administrators making it clear that on any other basis they would not have agreed to sell and assign the Trade Marks in accordance with the terms of the KM Purchase Agreement and this Agreement except for a higher consideration.

9. Severance

If any provision of this Agreement is or becomes illegal, invalid or unenforceable in any respect under the law of any jurisdiction, such provision shall be deemed to be severed from this Agreement and the Parties shall replace such provision with one having an effect as close as possible to the deficient provision. The remaining provisions will remain in full force in that jurisdiction and all provisions will continue in full force in any other jurisdiction.

10. Variations

No variation of this Agreement shall be effective unless it is made in writing and signed by or on behalf of each of the Parties.

11. Waivers and Remedies

- 11.1 No waiver of any right or remedy under this Agreement shall be effective unless given in writing. Unless expressly stated otherwise, a waiver shall be effective only in the circumstances for which it is given.
- 11.2 No delay or omission by any Party in exercising any right or remedy provided by law or under this Agreement shall constitute a waiver of such right or remedy.
- 11.3 The single or partial exercise of a right or remedy under this Agreement shall not preclude any other nor restrict any further exercise of any such right or remedy.

12. Costs and Expenses

Except as provided otherwise, each Party shall pay its own costs and expenses in connection with the negotiation, preparation and performance of this Agreement.

13. Rights of Third Parties

Except for any member of the Administrators' firms or any servants, agents or advisors of the Administrators, a person who is not a party to this Agreement shall have no rights under the Contracts (Rights of Third Parties) Act 1999 ("Act") to rely upon or enforce any term of this Agreement, provided that this does not affect any right or remedy of the third party that exists or is available apart from that Act. No Party may declare itself as a trustee of the rights under this Agreement for the benefit of any third party save as expressly provided in this Agreement.

14. Entire Agreement

- 14.1 This Agreement, together with any other documents referred to in it, constitutes the whole agreement between the Parties relating to the subject matter of this Agreement at the date of this Agreement to the exclusion of any terms implied by law which may be excluded by

contract and supersedes any previous written or oral agreement between the Parties in relation to the matters dealt with in this Agreement.

- 14.2 Each Party acknowledges that, in entering into this Agreement, it is not relying on any representation, warranty or undertaking not expressly incorporated into it.
- 14.3 A Party's only right or remedy in relation to any provision of this Agreement shall be for breach of this Agreement and no Party shall have any right or remedy in respect of misrepresentation (whether negligent or innocent and whether made prior to and/or in this Agreement).
- 14.4 Nothing in this Clause 14 limits or excludes any liability for fraud.

15. Dealing with Rights and Obligations

- 15.1 No Party may assign, transfer, create any trust over, charge or otherwise encumber or deal in any other manner with all or any of its rights and obligations under this Agreement (including any cause of action arising in connection with it) without the prior written consent of the other Parties. Any such purported action shall be ineffective.
- 15.2 During the Trading Period, the Assignee may not assign any of its right, title or interest in any of the Trade Marks to any person, unless such person has agreed in writing to be bound by the terms of the licence executed pursuant to Clause 7 by and between the Assignee (as licensor) and the Assignors (each as a licensee) regarding the Trade Marks.

16. Counterparts

This Agreement may be executed in counterparts, and shall be effective when each Party has executed a counterpart. Each counterpart shall constitute an original of this Agreement, but all the counterparts shall together constitute one and the same instrument.

17. Governing Law and Jurisdiction

- 17.1 This Agreement and any non-contractual obligations arising out of or in connection with it is governed by and shall be construed in accordance with English law.
- 17.2 Each of the Parties irrevocably agrees that the courts of England shall have exclusive jurisdiction to settle any dispute or claim which may arise out of or in connection with this Agreement and that accordingly any proceedings arising out of or in connection with this Agreement or its subject matter or formation shall be brought in such courts. Each of the Parties irrevocably submits to the jurisdiction of such courts and waives any objection to proceedings in any such court on the ground of venue or on the ground that the proceedings have been brought in an inconvenient forum.
- 17.3 Each of the Parties agrees that in the event of any action between any of the Parties being commenced in respect of this Agreement or any matters arising under it, the process by which it is commenced (where consistent with the applicable court rules) may be served on them in accordance with Clause 18 of the KM Purchase Agreement save that email service will be excluded from any legal process or proceedings under this Clause 17.3.

This Agreement has been entered into by the Parties on the date first above written.
