RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS

This **RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS** dated as of April 1, 2021 (this "Release") is made by **MIDCAP FINANCIAL TRUST**, in its capacity as collateral agent (in such capacity, together with its successors and permitted assigns, the "Collateral Agent") with respect to that certain Security Interest in Trademark Rights, dated as of December 31, 2019 (the "Trademark Security Agreement") by and among **TTF HOLDINGS, LLC (F/K/A SOLIANT HOLDINGS, LLC)**, a Delaware limited liability company and **VOCOVISION, LLC**, a Delaware limited liability company (**F/K/A VOCOVISION, INC.**, a Delaware corporation) (the "Grantors" and each, a "Grantor") and the Collateral Agent. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement or the Security Agreement, as applicable.

WHEREAS, pursuant to (i) that certain Security Agreement, dated as of December 31, 2019, by and among the Grantors, the other Persons party thereto, and the Collateral Agent (together with all amendments, restatements, supplements and modifications, if any, from time to time thereafter made thereto, the "Security Agreement"), and (ii) the Trademark Security Agreement, which was recorded in the records of the United States Patent and Trademark Office on January 2, 2020 at Reel 6829, Frame 0957, each Grantor granted to the Collateral Agent, for the benefit of the Secured Parties, a lien on and security interest in all of such Grantor's right, title and interest in, to and under the Collateral (as defined in the Trademark Security Agreement, including those Trademarks set forth on Schedule A attached hereto) (the "Security Interest");

WHEREAS, pursuant to that certain Payoff Letter, dated as of April 1, 2021, by and between, among others, the Grantors and the Collateral Agent, the Grantors have requested and the Collateral Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of the Security Interest.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate and cancel (i) the Trademark Security Agreement and (ii) the Security Interest and any other lien created under the Trademark Security Agreement in the Collateral, (b) release the Security Interest and any other lien in the Collateral in its entirety, and (c) discharge any and all rights, title and interest it has in and the Security Interest and any other lien granted to the Collateral Agent in the Collateral.

This Release may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original.

This Release shall be governed by, and construed in accordance with, the laws of the State of New York.
