## EXECUTION VERSION

### TRADEMARK RELEASE

THIS TRADEMARK RELEASE (this “Release”) is made as of April 1, 2021, by MEDLEY CAPITAL LLC, in its capacity as agent for the Secured Parties (the “Agent”), in favor of WALKER EDISON FURNITURE COMPANY LLC, a Utah limited liability company (“Grantor”), pursuant to the Security Agreement (as defined below). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Credit Agreement (as defined below) or the Security Agreement, as applicable.

#### WITNESSETH:

WHEREAS, pursuant to the terms and conditions of that certain Term Loan Agreement, dated as of September 26, 2018 (as amended, restated, amended and restated, supplemented, or otherwise modified to date, the “Credit Agreement”), by and among Grantor, the other Loan Parties party thereto from time to time, the Lenders party thereto from time to time and Agent, Grantor entered into that certain Security Agreement, dated as of September 26, 2018 (including all annexes, exhibits or schedules thereto, as amended, restated, supplemented or otherwise modified to date, the “Security Agreement”), by and among Grantor, the other Grantors party thereto and the Agent, Grantor granted and pledged to the Agent, for the benefit of the Secured Parties, a continuing security interest in all of Grantor’s right, title and interest in and to the Collateral;

WHEREAS, Grantor and the Agent are parties to that certain Trademark Security Agreement, dated as of September 26, 2018 (including all annexes, exhibits or schedules thereto, as amended, restated, supplemented or otherwise modified to date, the “Trademark Security Agreement”), pursuant to which Grantor has granted a security interest (the “Security Interest”) to the Agent, for the benefit of the Secured Parties, in the Trademark Collateral (as defined below), including the Trademarks set forth on Schedule I hereto;

WHEREAS, the Trademark Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on September 27, 2018 at Reel 006466, Frame 0638; and

WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral;

NOW THEREFORE, in consideration of the foregoing and for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, subject to the terms and conditions of the Security Agreement, the Agent hereby states as follows:

1. The Agent hereby terminates the Trademark Security Agreement and terminates, releases, and discharges its Security Interest, and all of its right, title and interest in, to and under the following (collectively the “Trademark Collateral”) shall hereby cease and become void:

a. all of the Trademarks and Trademark Licenses to which Grantor is a party, including those referred to on Schedule I;

b. all goodwill of the business connected with the use of, and symbolized by, each Trademark and each Trademark License; and

c. all products and proceeds (as that term is defined in the Code) of the foregoing, including any claim by Grantor against third parties for past, present or future (i) infringement or dilution of any Trademark or any Trademarks exclusively licensed under any Trademark License, including the right to receive any damages, (ii) injury to the goodwill associated with any

Trademark, or (iii) right to receive license fees, royalties, and other compensation under any Trademark License.


2. The Agent hereby agrees, at Grantor's expense, to execute and deliver to Grantor such documents, instruments, notices and releases as Grantor shall reasonably request to evidence the release of the Security Interest contemplated hereby. The Agent agrees, or authorizes the Grantor, to make filings with the Trademark Division of the United States Patent and Trademark Office and take further actions, as reasonably requested by the Grantor to evidence the release and termination of the Agent's Security Interests in the Trademark Collateral.

3. THIS RELEASE SHALL BE GOVERNED BY, AND SHALL BE CONSTRUED AND ENFORCED IN ACCORDANCE WITH, THE INTERNAL LAWS OF THE STATE OF NEW YORK, APPLICABLE TO CONTRACTS MADE AND PERFORMED IN THAT STATE. The terms of Sections 10.14 ("Governing Law") and 10.15 ("Waiver of Jury Trial") of the Credit Agreement are incorporated herein by reference, *mutatis mutandis*, and the parties hereto agree to such terms.
