BILL OF SALE AND ASSIGNMENT

THIS BILL OF SALE AND ASSIGNMENT is made as of the 30th of September, 2020, by and between THE FIREHOUSE BREWING CO., d/b/a The Firehouse Brewing Co., a sole proprietorship ("Seller"), and FAT BOYS INC., d/b/a Firehouse Brewing Co, a South Dakota corporation ("Buyer").

In consideration of a total purchase price of \$7,000.00, that has been satisfied by good and valuable consideration, the specifics of which are enclosed within the Purchase and Sale Agreement dated September 30th, 2020, between Buyer and Seller, the receipt and sufficiency of which hereby acknowledged, Seller sells, assigns, transfers, conveys, and delivers to Buyer all of Seller's right, title, interest, and goodwill in and to the pending trademark known as THE FIREHOUSE BREWING COMPANY, Serial No. 78/477,034, filed on September 01, 2004, for goods and services in International Class 040 for "[c]ustom manufacture of beer" (the "Firehouse Trademark"), as well as any Assets in use, now or in the future, that use the words "Firehouse Brewing."

Seller shall deliver any and all other instruments or documents required to be delivered pursuant to, or necessary and/or proper in order to give effect to, the provisions of this Bill of Sale, including, without limitation, all instruments of transfer as may be necessary or desirable to transfer title to all of the Seller's rights in and to all the assets and to consummate the transactions contemplated by this Bill of Sale. When reasonably requested by Buyer, Seller agrees to cooperate with Buyer in connection with any disputes or litigation involving ownership or use of the asset that may arise after the date hereof.

This Bill of Sale shall also constitute an assignment of Seller's entire right, title, interest, and goodwill in any international or online Assets for which an assignment is necessary or appropriate to transfer such right, title, interest, and goodwill.

This Bill of Sale shall be governed by and construed in accordance with the laws of the State of South Dakota without giving effect to any conflicts of law provisions.
