RELEASE OF SECURITY INTEREST

This Release of Security Interest (this "Release") is executed as of January 29, 2021 by COMERICA BANK ("Assignor") for the benefit of VIX, INC., a Delaware corporation (f/k/a: Batanga, Inc.) RECITALS

A. B. WHEREAS, Assignor wishes to release all interest that Assignor may have in the Intellectual Property.

AGREEMENT

1. Now, therefore, Assignor agrees that it hereby terminates the IP Security Agreement, and hereby terminates, cancels, discharges and releases any and all security interests it has in the Intellectual Property and hereby reassigns to Assignee, without warranty or recourse, all interests of Assignor in the Intellectual Property.

2. Assignor shall, at the Assignee's expense, take all further actions, and provide to the Assignee, its successors, assigns and other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Assignee to more fully and effectively effectuate the purposes of this Release.

3. Assignor hereby authorizes the Assignee to record this Release with the United States Patent and Trademark Office, and any other relevant agency throughout the world.

4. This Release shall be governed by and construed in accordance with the laws of the State of California.
