

With respect to the DR. REDDY’S LTD.’S TRADEMARKS, Dr. Reddy’s, Inc. is, as assignee, the successor to the business identified by the DR. REDDY’S LTD.’S TRADEMARKS previously owned by Dr. Reddy’s Ltd. and now owned by Dr. Reddy’s, Inc. Dr. Reddy’s Ltd. agrees to cooperate with Dr. Reddy’s, Inc. to convey, perfect, record, and otherwise take steps to further the conveyances and rights granted herein.
