**AFFIDAVIT TO AFFIRM THE RELEASE OF
SECURITY AGREEMENT - TRADEMARKS**

This Affidavit to Affirm the Release of Security Agreement (“Affidavit”) is effective as of March 1, 2019 pursuant to the fulfillment of the loan obligations.


I, Nicole Strothman, do hereby declare as follows:

I am the General Counsel, Secretary of **Ideal Image Development Corporation.**, a Florida Corporation, located at **1 N. Dale Mabry Hwy #1200, Tampa, FL 33609** (“Company”).

1. Pursuant to that certain Security Agreement, dated as of December 9, 2015 (the “Security Agreement”), Company granted a security interest to Newstar Financial, Inc. (the “Collateral Agent”) in the trademark registrations set forth on Schedule A attached hereto (the “Trademarks”).
2. The Security Agreement was recorded at the U.S. Patent and Trademark Office (the “USPTO”) with respect to the trademarks on December 9, 2015 at Reel 5685 Frame 0424.
3. To the best of my knowledge, the obligations secured under the Security Agreement were satisfied with the issuance of the payoff letter dated March 1, 2019 by the Collateral Agent. Company repaid all its outstanding loans and other Obligations (as defined in such payoff letter) in full, and the Collateral Agent, on behalf of itself and the Lenders (as defined in such payoff letter, terminated and released its security interest in the Trademarks under such payoff letter.
4. Due to unknown reasons, a release of the Security Agreement has not been filed with the USPTO.
5. I, being hereby advised that willful false statements and the like so made are punishable by fine or imprisonment, or both, under 18 U. S. C. 1001, declare that: the facts set forth in this Affidavit are true; all statements made of my own knowledge are true; and all statements made on information and belief are believed to be true.
6. I have personal knowledge of these facts and attest to their truth.
